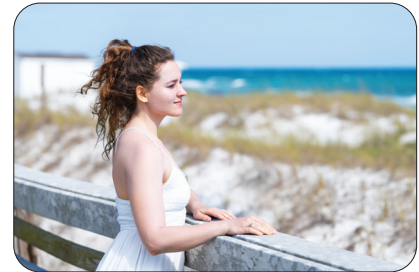

### EXHIBIT BOOTH SPECIFICATIONS AND INFORMATION

Our meeting will be at the Sandestin Golf and Beach Resort. **Do not ship your materials to the hotel.** You can make such arrangements through Veal Convention Services at 205-328-1010.

Booths are 8 feet wide by 8 feet deep. The back drape of the booth is 8 feet high. Each booth comes with back and side drapes, a draped 6-foot table, a wastebasket and two chairs. After you register, we will send you the necessary form to order electricity. There is an additional charge for any electrical or internet needs you may have. The hotel can also provide telephone connections, but it will need plenty of notice. There is an additional charge for phones.



Booth rates are \$2,000. **If cancellation is received after May 19, refunds are subject to a \$100 administrative fee. There will be NO REFUNDS after June 1.** Spaces are assigned on a first-come, first-served basis, according to the date of receipt of your registration.

Upon receipt of your booth registration, you will receive a written confirmation. We will provide a password and username for your use in ordering items or services from Veal Convention Services.

### RULES AND ADDITIONAL INFORMATION FOR EXHIBITORS

1. **All booths must be in place by 8 p.m. on Wednesday, June 24.** Your booth should be staffed at all times during viewing hours. No sales are permitted at exhibit booths.
2. Aisles must be kept clear; no banners, signs, etc., will be allowed to interfere with views of adjacent booths.
3. At the end of the show, you will be responsible for taking your empty boxes, etc., to the dumpsters provided by the hotel. If the hotel or Veal has to remove trash, there will be a \$50 charge per booth.
4. No subletting of space is permitted.
5. Drayage services will be available at the hotel on June 22nd for setup and on June 24th for takedown, or you may make your own arrangements.
